EXPLANATION OF "TAXING AUTHORITY INFORMATION" SECTION

Column 1 - "Last Year's Property Tax Information"

Shows the exemptions granted last year, how they were applied to each tax levy to calculate last year's taxable value, multiplied by the tax rate to reach the amount of taxes for each taxing authority.

Column 2 - "This Year's Exemptions" and "This Year's Taxable Value"

Shows the exemptions granted this year and how they were applied to each tax levy to calculate this year's taxable value.

Column 3 - "Your tax rate and taxes this year if NO budget change"

Shows what your tax rate and taxes will be IF EACH TAXING AUTHORITY DOES NOT CHANGE ITS PROPERTY TAX LEVY. These amounts are based on last year's budgets and your current assessment.

Column 4 - "Your tax rate and taxes this year if proposed budget change adopted"

Shows what your tax rate and taxes will be this year under the BUDGET ACTUALLY PROPOSED by each taxing authority. The proposal is NOT final and may be amended at the public hearings shown at the top of this notice.

EXPLANATION OF "PROPERTY APPRAISER VALUE INFORMATION" SECTION

MARKET (JUST) VALUE - The most probable sale price for a property in a competitive, open market involving a willing buyer and a willing seller.

ASSESSED VALUE - The value of your property after any "assessment reductions" have been applied. This value may also reflect an agricultural classification. If "assessment reductions" are applied or an agricultural classification is granted, the assessed value may be different for School versus Non-School taxing authorities and for the purpose of calculating tax levies.

ASSESSED VALUE REDUCTION - Properties can receive an assessment reduction for a number of reasons including the Save Our Homes Benefit and the 10% non-homestead property assessment limitation. Agricultural Classification is not an assessment reduction, it is an assessment determined per Florida Statute 193.461.

EXEMPTIONS - Any exemption that impacts your property is listed in this section along with its corresponding exemption value. Specific dollar or percentage reductions in assessed value may be applicable to a property based upon certain qualifications of the property or property owner. In some cases, an exemption's value may vary depending on the taxing authority. The tax impact of the exemption value may also vary for the same taxing authority, depending on the levy. (i.e.
